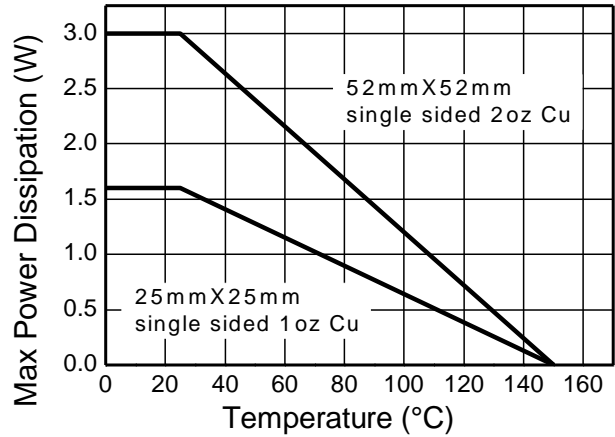


$V_{CE}$  - Collector Voltage (V)

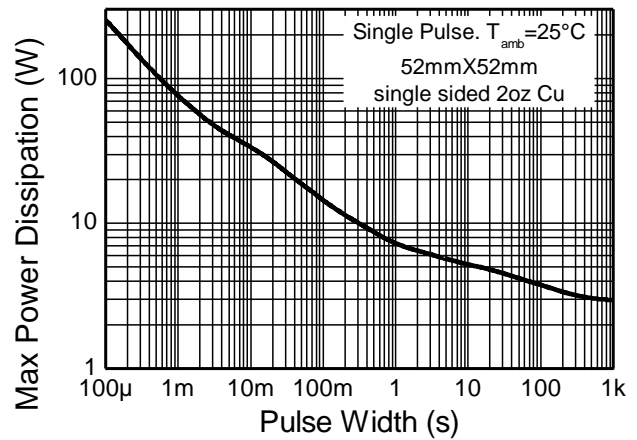
**Safe Operating Area**

**Derating Curve**



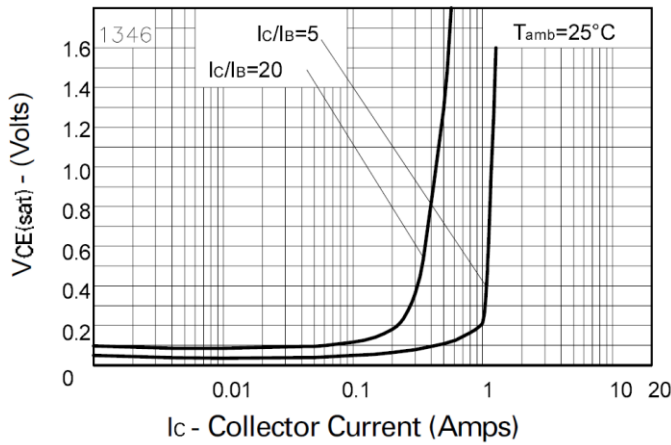

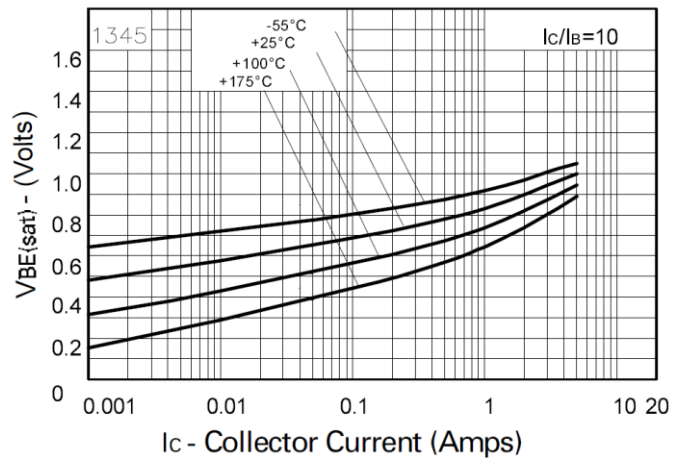
**VCE(sat) v IC**



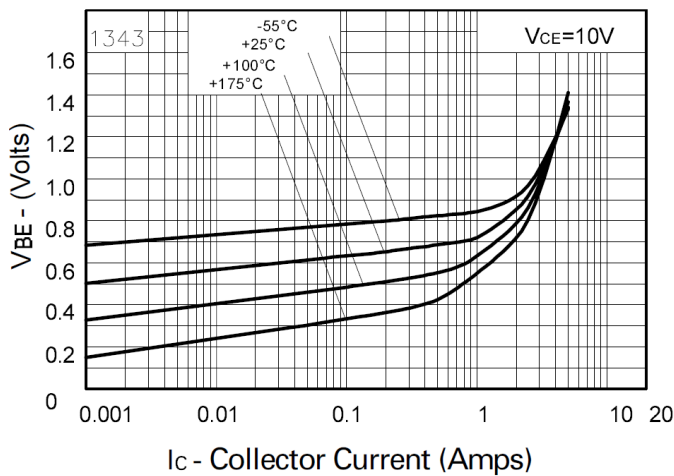
**VCE(sat) v IC**



**hFE v IC**



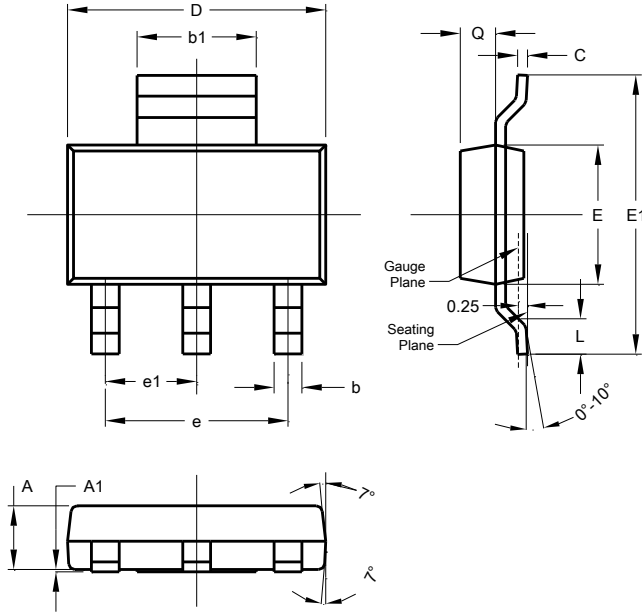
**VBE(sat) v IC**

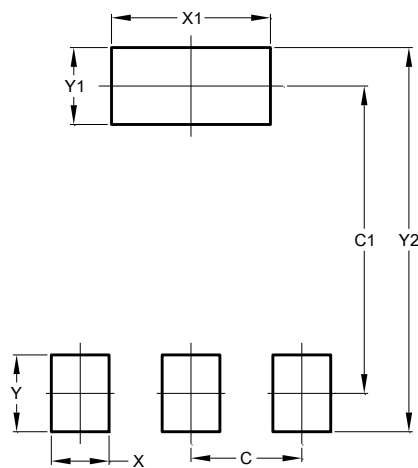
