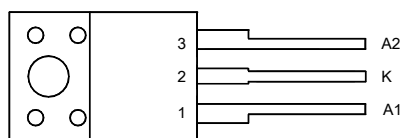

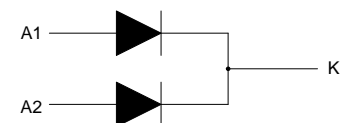

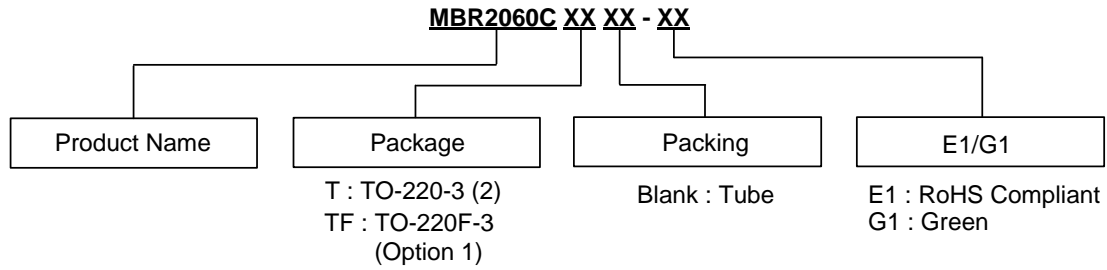

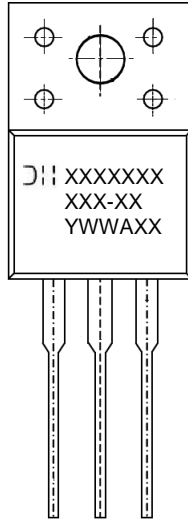

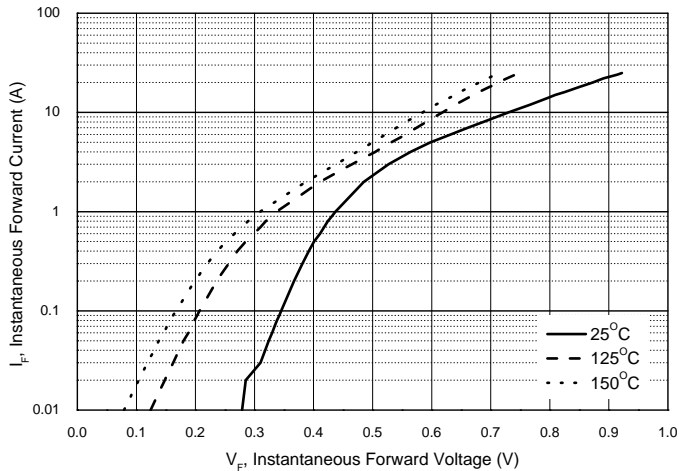


Figure 1. Typical Forward Voltage

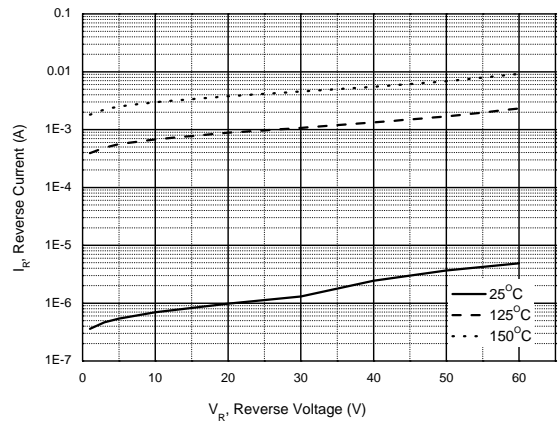


Figure 2. Typical Reverse Current

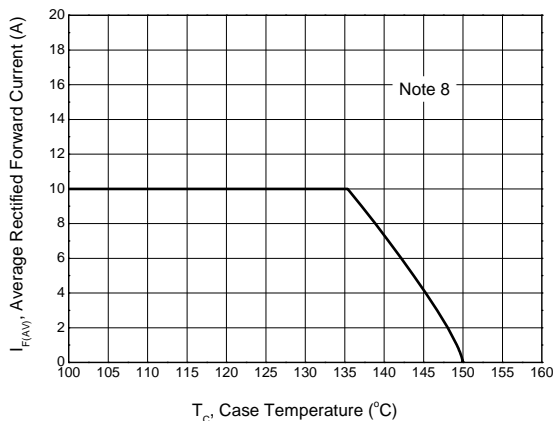
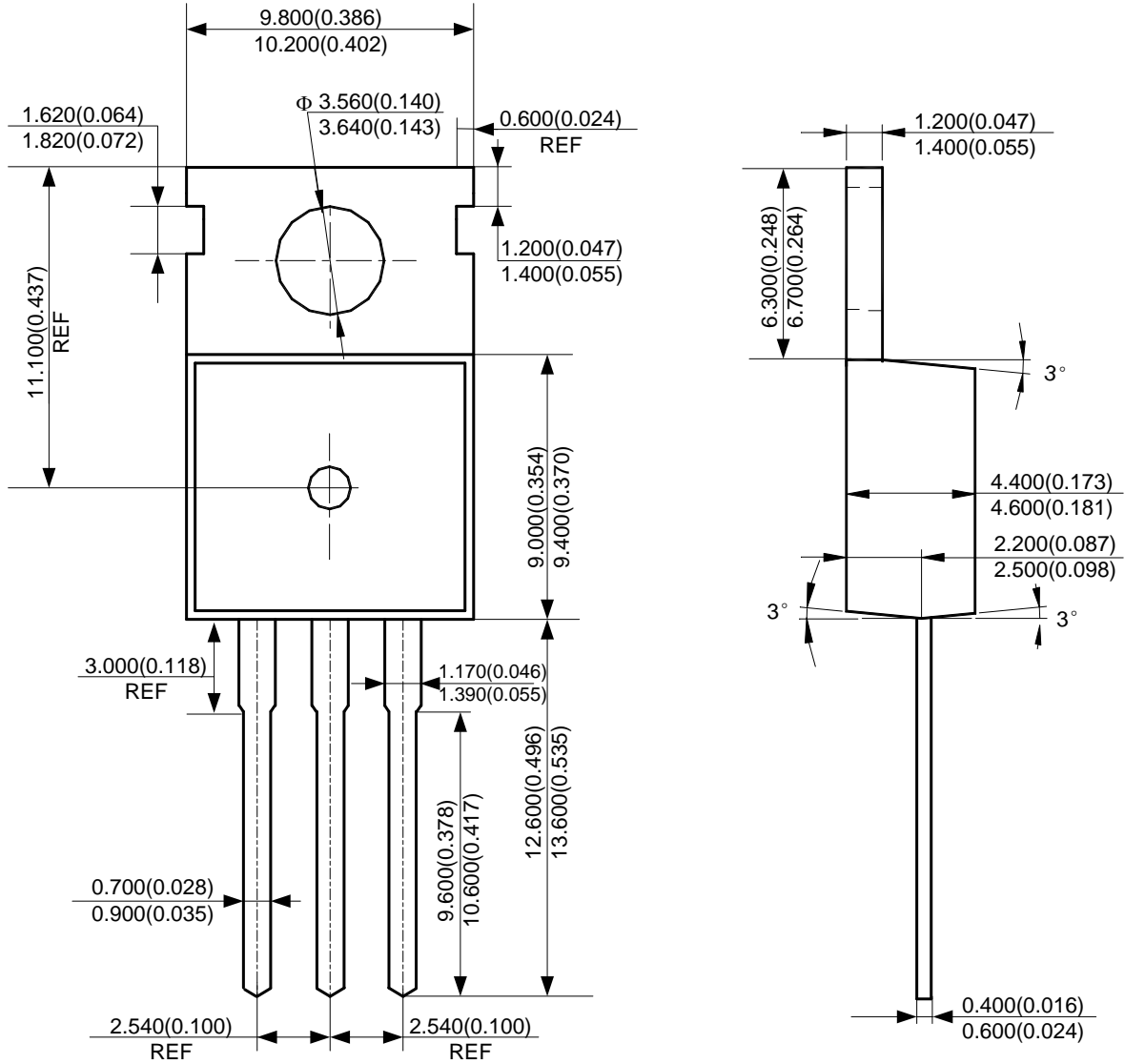


Figure 3. Average Rectified Forward Current vs. Case Temperature (Per Diode)

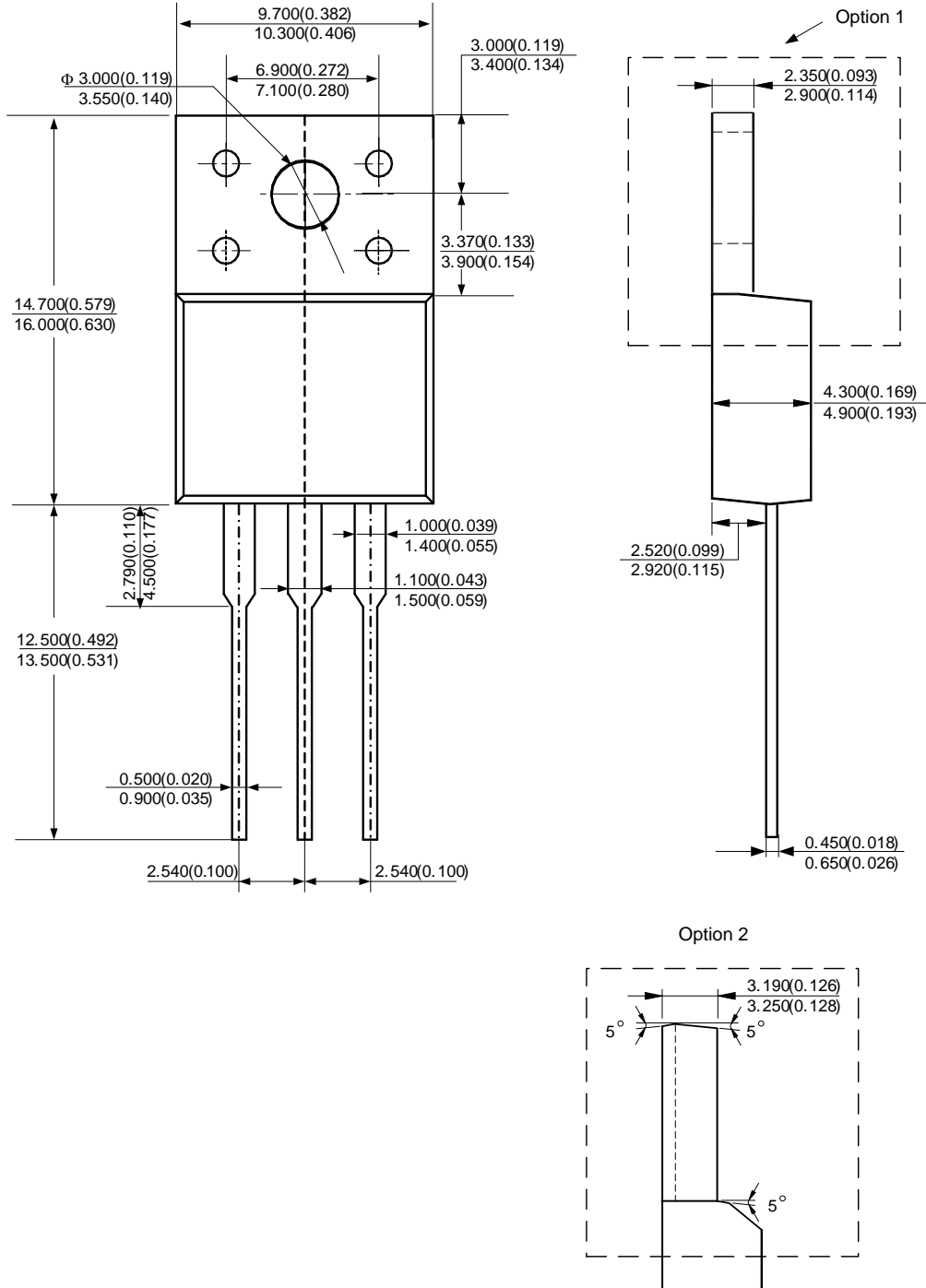
