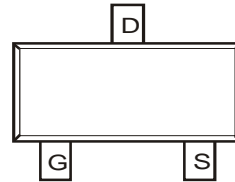

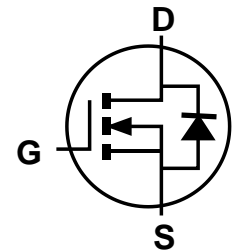

Pin Configuration



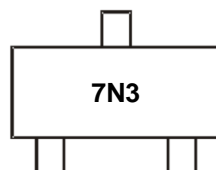
Equivalent Circuit

Package Outline Dimensions

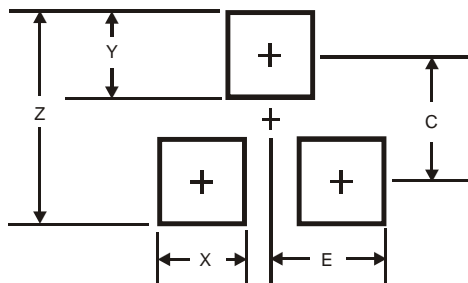
