**Derating Curve**



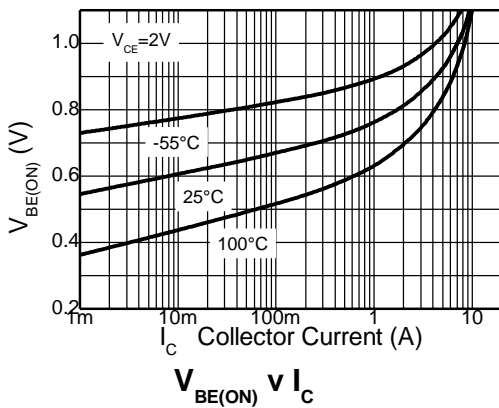
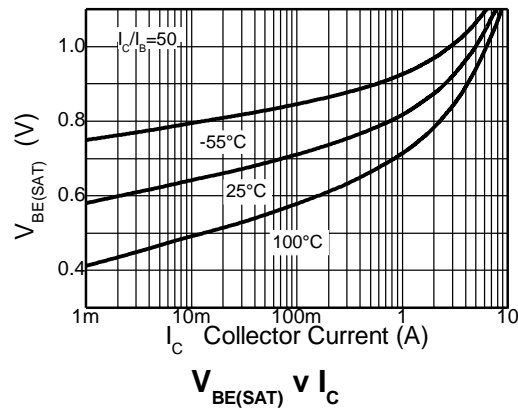
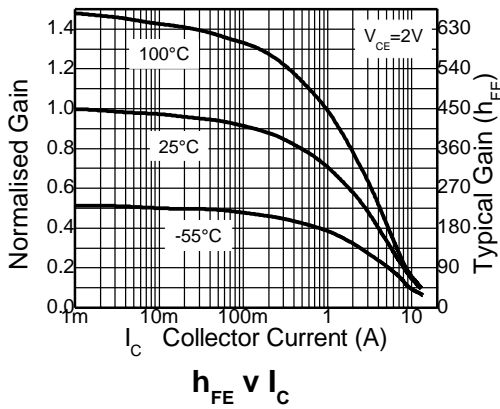
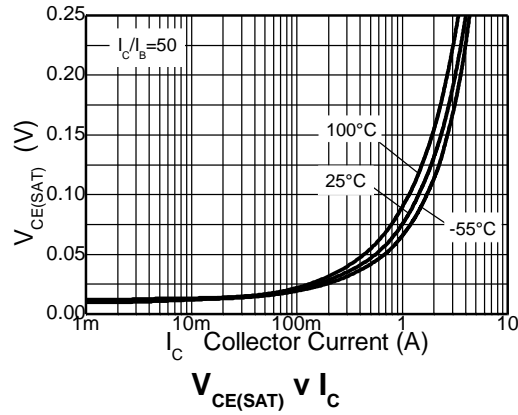
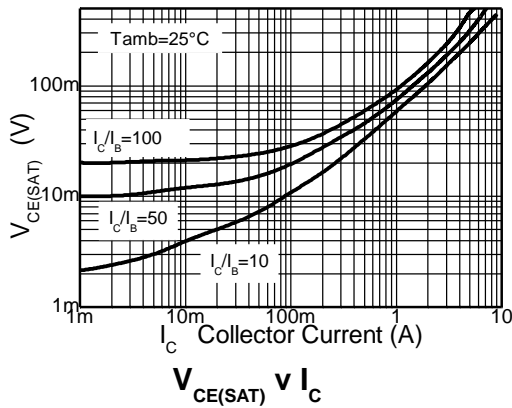
